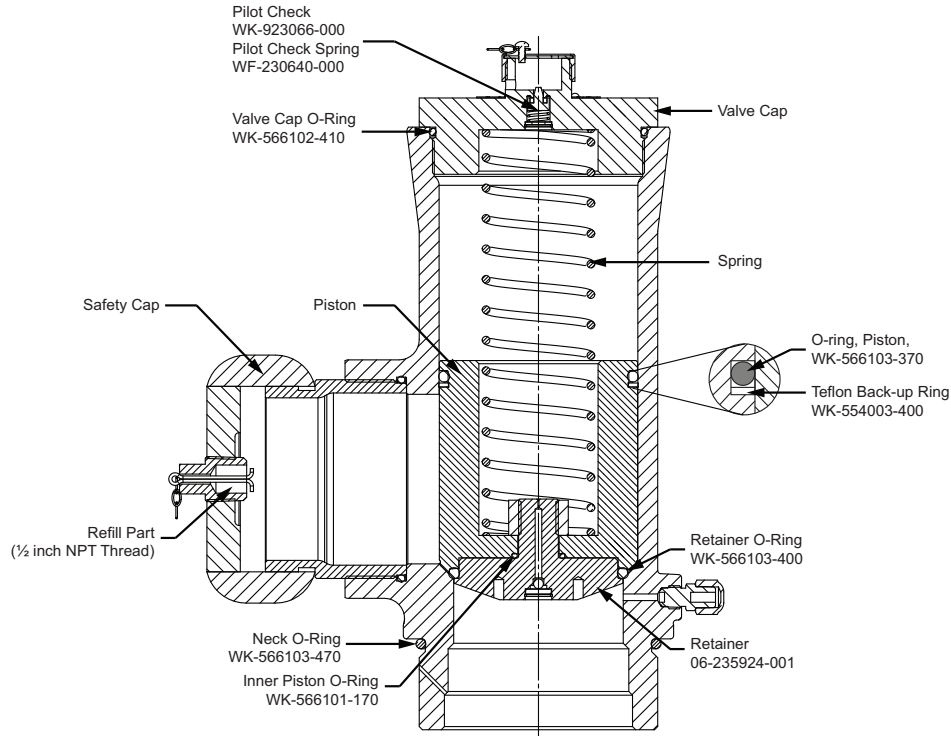


Figure 1. 3-inch Valve Assembly
