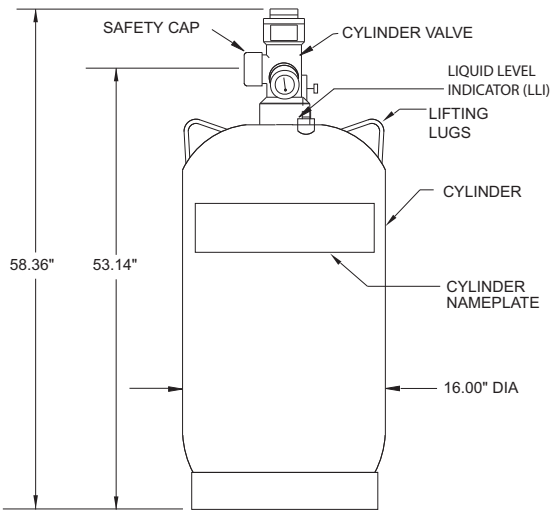
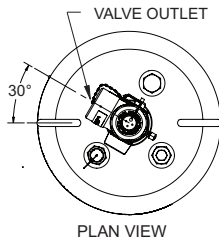

Notes:

1. The safety cap must be installed on the valve outlet at all times, except when the cylinders are connected to the system piping, or being filled. The safety cap must not be removed from its chain.
2. Cylinders manufactured prior to May 2014 have only 1 boss. The safety burst disk and other port are on the valve.
3. For marine applications, 2 straps may be required, consult the local authority having jurisdiction. For 350 lb. (142 L) agent cylinders in marine applications, a cradle is required between the cylinder and the unistrut or bulkhead for support.
