DESCRIPTION

The Kidde Fire Systems Model 878752 Abort Station features a large, easy-to-operate abort push button. The momentary type switch is easy to see due to its highly visible yellow color. The Abort Station stainless steel faceplate is clearly labeled with operation procedures. The backbox is painted with red enamel and is provided with four 1/2-inch knockouts. The pre-drilled and tapped mounting tabs allow for easy attachment.

To make the Abort Station an addressable SLC device for use with Kidde Fire Systems intelligent control units operating SmartOne® protocol, one Model AI monitor module (purchased separately) must be installed into the backbox. The Model AI monitor module is seated inside a bracket (included) and easily installs with two mounting screws.

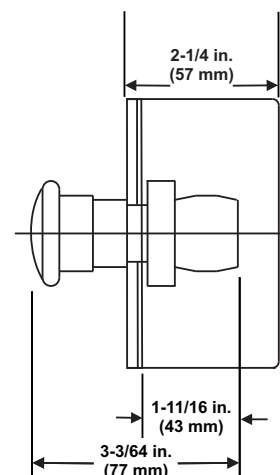
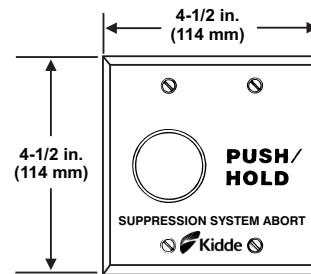


Figure 1. Dimension Details
